(2) Scientific significance

I made a presentation with the title of "Comparative analysis of Community Solar Projects between Thailand and Japan" at Tri-U conference and Chulalongkorn University. Community-solar (CS) has appeared as a new solar PV ownership model in the word, in which the business model of CS should vary depending on each country's context. Various unique factors of each country such as the design of the government's support, characteristics of the community, and business custom may have an impact on how community members benefit from CS projects. The objective of this research is to compare the implemented CS projects in Thailand and Japan and to provide policy recommendation on CS for both countries based on comparison for contribution to further development of CS. The condition of community solar projects in Thailand and Japan was not investigated enough, and this research made it clear and became a first step for next stage of community solar projects.
